<b>Freight Charges</b>	FOB Origin, Prepaid and Invoiced based on LFI 2021 Freight zone charges
<b>Delivery Terms</b>	Standard LF 45 Day Dock Delivery. Add Lift Gate Fee if required
<b>NCPA Direct End Users (LF)</b>	NCPA customers may order directly from Landscape Forms as the manufacturer
<b>TX NCPA Auth Dealers</b>	NCPA customers may also order from Landscape Forms thru <a href="#">Designated NCPA Dealers within the State of Texas as listed here</a>  Designated Dealer have the authority to accept Eligible NCPA Customer purchases orders and may invoice customers directly
<b>Inside Delivery (as offered By LF Direct or by Dealer)</b>	Standard Inside Delivery Services may be offered at a flat rate of 12% of NCPA Net product pricing. Inside Delivery consists of delivery to a location beyond the dock, unpackage, minor assembly, setting in place and removing debris. Prevailing Wage Rate Inside Delivery Services are offered at a rate that is negotiable with customer based on their scope of work and may not exceed 20% Rates are subject to final agreement by the customer.
<b>Invoicing</b>	Landscape Forms or designated NCPA Dealers shall invoice customers and receive payments for products and services as quoted and applicable.
<b>Installation</b>	Major installation is not included in this contract and should be purchased separately
